## President's Notes

We were notified on January 1st that Abbiati Dental and Medical Office Building was to be built on the vacant property on the southside of the US41 entrance to Fountain Lakes. What a way to start the new year -2022.

On January 7th, the Dental group presented an overview of their project to the Fountain Lakes President, Vice President, Community Manager, and lawyer. Following the presentation, we expressed concerns regarding the use of Fountain Lakes Blvd for the entrance causing safety issues, intrusion from the lighting and parking noise behind the Sungate neighborhood, the size of the building is not being specific, the style of the building, location of the parking, and stormwater drainage.

A special Fountain Lakes board meeting was held on January 10th to inform the residents of Fountain Lakes what we knew about the project and to listen to their concerns. Everyone in attendance recognized a huge safety issue exists with this situation especially when you consider the existing congestion experienced at our call box. When the Lockup Storage, which is the property to the south of the Dental property, was built, the city required them to install and ingress/egress on their drive for entry to the Abbiati property. We believe that is a much safer alternative than Fountain Lakes BLVD. The Sungate and the other issues were discussed. We currently have our lawyer involved and have hired a land development lawyer to help us. It was determined the best way to approach the situation was as a safety concern. We are getting bids to do our own traffic study.

On January 11, The Village of Estero Planning, Zoning, and Design Board held a meeting. The Banks Engineering firm presented the plans for the Abbiati Complex. This was an informational meeting as no permits had been submitted to the board. Two of the Estero board members were very adamant that the use of Fountain Lakes Blvd is a safety hazard and the Lockup Storage ingress/egress is a better solution.

Fountain Lakes Board members at the meeting were Ryan Willoughby, Janet Hildebrand, Lori Smith, Bill Covitz, and Joyce Siska. These board members expressed their concerns as well as several Fountain Lakes residents who attended the meeting.
