Notes from Fountain Lakes Community Association (FLCA) President

The FLCA budget and reserve study were presented at the November 6th Board of Govoners meeting. There will NOT be an increase in the Master Association dues. They will stay at \$350 per quarter per door. The reserve study provided a complete outlook of the upcoming maintenance for Fountain Lakes assets over the next 30 years. You will soon receive a copy of the budget and reserve study either by email or snail mail.

Owners voted for an audit in 2023 which is still being reviewed. Owners also voted for an audit in 2024 which will not take place until the end of 2024. The cost for the 2024 audit is \$5,000.

#### Dear Fountain Lakes Community Members,

We want to keep you informed about the current status of the Abbiati Dental development at our community's front entry. This project has been an ongoing and evolving issue, and the FLCA Board has been working diligently to protect the interests of our community.

We are pleased to announce that we have reached a settlement agreement with the Abbiati developer.

• The developer has agreed to cover the cost of relocating our front gates. This relocation will enhance safety for both the Fountain Lakes Community and the Abbiati Dental property.

• The easement on Fountain Lakes Blvd. for the Abbiati property has been modified to better serve our community's needs.

To ensure that the new gate placement meets all traffic safety standards, the FLCA Board is working with traffic engineers to evaluate the relocation design provided by Abbiati. Once we are confident that the new design allows safe ingress and egress on Fountain Lakes Blvd. for our residents, we will move to the permitting stage for the Abbiati property's development. Throughout this process, the Board will remain vigilant to ensure that the terms of the settlement agreement are fully honored and that our community's best interests are protected.

At our last Board meeting, we discussed the possibility of FLCA acquiring the Abbiati property. Please note that this is only an exploratory consideration at this stage, and no decision has been made. The property is currently for sale, and the Board believes it is prudent to explore all options that could benefit the Fountain Lakes Community.

To assess the feasibility of such an acquisition, we are gathering information on interest rates and loan options. Additionally, we are reviewing FLCA's financial position to determine whether a purchase would be beneficial for our community.

The Board is also considering the implications if the Abbiati property were sold to a different buyer. Our main concerns include:


• Legal Considerations: Whether our existing settlement agreement with the developer would remain legally binding if the property is transferred to a new owner. • FLCA's Position: Identifying any proactive steps we may need to take now to protect our interests and mitigate potential risks if the property changes hands.

The Board will continue to evaluate these questions as we seek to ensure the best outcome for our community.

- I. First Notice: January 20, 2025
  - Look out for the election notice via mail. Notices are sent to the address on record, which may be a summer address for part-time residents.
- 2. Intent to Run: February 9, 2025
  - Deadline for potential candidates to submit their Notice of Intent forms.
- 3. Candidate Information Sheets: February 14, 2025
  - Candidates can submit informational sheets, which are recommended but not required.
- 4. Second Notice: February 19, 2025
  - Includes candidate information sheets, proxy form, ballot, and envelopes. Essential for voting; if not received, copies are available at the office.
- 5. Board Meeting Agenda: March 7, 2025
  - Posted on the Fountain Lakes website and at the community center.
- 6.Annual Meeting and Election Night: March 21, 2025
  - Takes place at the community center.
- 7. The FLASH will publish candidate information sheets and a sample ballot in the March edition. Sample ballot is for reference only and cannot be used for voting.

## **Voting Options**

- I. Proxy Voting; Complete a proxy form to allow a designated person to vote on your behalf at the annual meeting. It is advisable and requested that proxy designation be done as early as possible so management can determine participation to establish a quorum for the meeting. This can be done by dropping off your proxy or mailing to the office.
- 2. In-Person or Drop-Off Voting: Submit your ballot at the office or fill one out there after February 19, 2025. \*\*\*BE SURE TO SIGN YOUR BALLOT ENVELOPE AND INCLUDE YOUR ADDRESS for without that information your vote will not be counted\*\*\*\*
- 3. Election Night Voting; Vote in person on March 21, 2025, at the community center.
